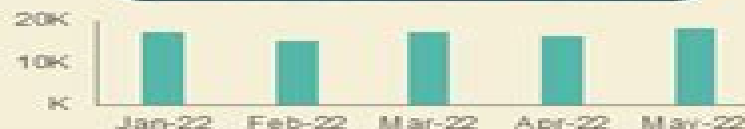

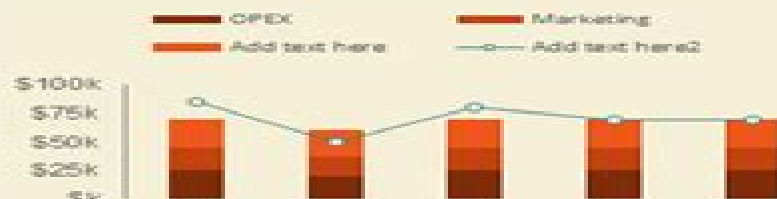

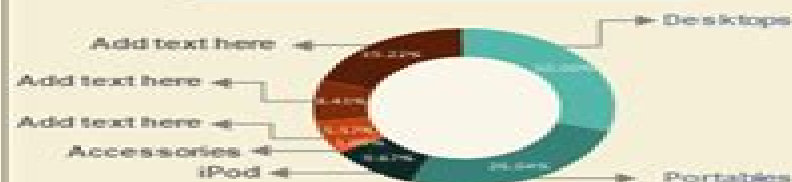

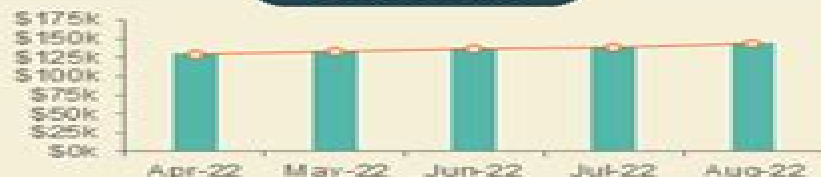


Revenue Breakdown
