1. That the Amended Motion is well taken and should, in all things, be GRANTED;
2. That Daingerfield-Lone Star Independent School District conducted the May 7, 2016 election of the At-Large Trustee positions in accordance with Texas law;
3. That Contestee Marie Skipper was a candidate for the At-Large Position #3 Daingerfield - Lone Star Independent School District Trustee position in the May 7, 2016 school board election;
4. That Contestant Cody Wommack was a candidate for the At-Large Position #4 Daingerfield - Lone Star Independent School District Trustee position in the May 7, 2016 school board election; and
5. That Contestant Cody Wommack has no standing to file an election contest against Contestee Marie Skipper.
