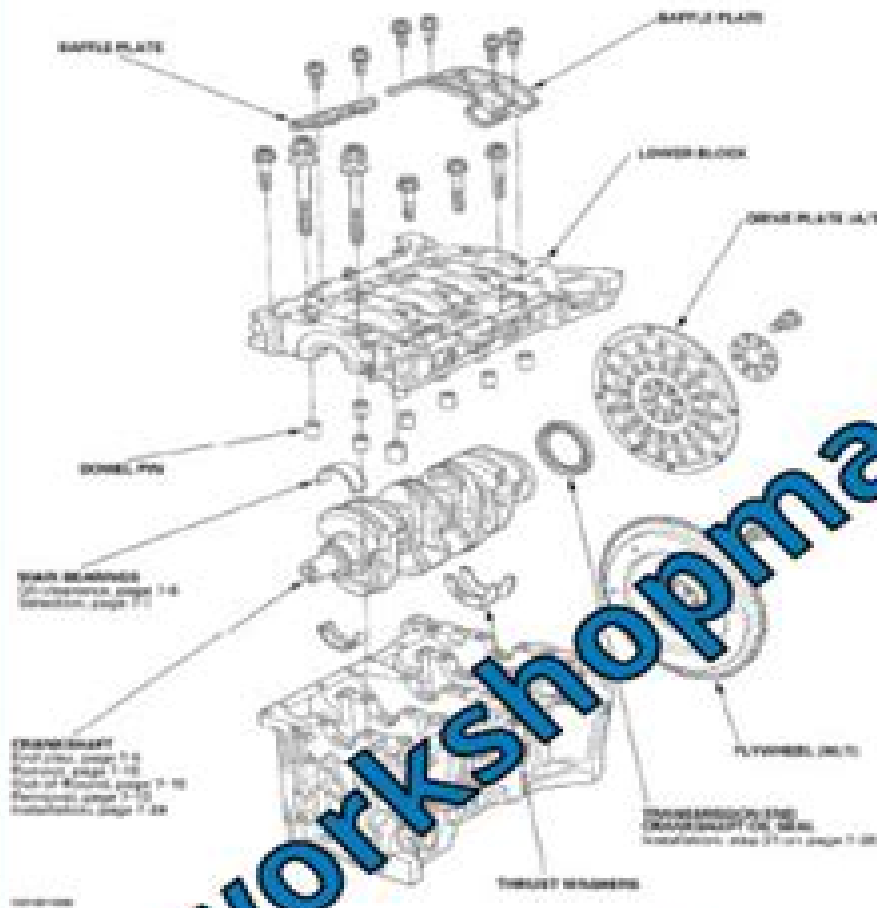


Fig. 181 Exploded View Of Engine Block Components (1 Of 2)
