Small Business Administration Hubzone Program Congressional Research Service,2015-02-11 The Small Business Administration SBA administers several programs to support small businesses including the Historically Underutilized Business Zone Empowerment Contracting HUBZone program The HUBZone program is a small business federal contracting assistance program whose primary objective is job creation and increasing capital investment in distressed communities It provides participating small businesses located in areas with low income high poverty rates or high unemployment rates with contracting opportunities in the form of set asides sole source awards and price evaluation preferences Firms must be certified by the SBA to participate in the HUBZone program On February 11 2015 there were 5 553 certified HUBZone small businesses In FY2013 the federal government awarded 64 912 contracts valued at 6 54 billion to HUBZone certified businesses with about 1 87 billion of that amount awarded through a HUBZone set aside sole source or price evaluation preference award The program s FY2013 administrative cost was about 10 0 million Its FY2015 appropriation is 3 0 million with the additional cost of administering the program provided by the SBA s appropriation for general administrative expenses Congressional interest in the HUBZone program has increased in recent years primarily due to U S Government Accountability Office GAO reports of fraud in the program Some Members have called for the program s termination Others have recommended that the SBA continue its efforts to improve its administration of the program especially its efforts to prevent fraud This report examines arguments both for and against targeting assistance to geographic areas with specified characteristics such as low income high poverty or high unemployment as opposed to providing assistance to people or businesses with specified characteristics It then assesses the arguments both for and against the continuation of the HUBZone program

Manuel,2013-11 This report discusses what constitutes a disadvantaged small business for purposes of federal and federally funded contracting programs and how firms are certified or otherwise designated as such Three primary categories of disadvantaged small businesses are currently eligible for various contracting programs 1 small businesses participating in the Small Business Administration s SBA s Minority Small Business and Capital Ownership Development Program commonly known as the 8 a Program 8 a participants 2 small disadvantaged businesses SDBs and 3 disadvantaged business enterprises DBEs These firms are characterized as disadvantaged because they are at least 51% owned by one or more socially and economically disadvantaged individuals or groups However social and economic disadvantage is defined somewhat differently for each program Members of certain racial and ethnic groups are presumed to be socially disadvantaged for purposes of the 8 a and SDB programs while women are also presumed to be socially disadvantaged for purposes of the DBE program Similarly individuals net worth must be 250 000 or less for entry into the 8 a Program while net worth can be as high as 750 000 for newly designated SDBs or DBEs The programs for the various types of firms also differ in their operation The 8 a Program is open only **Sba Surety Bond Guarantee Program** Congressional Research Congressional Research Service,2014-12-05 The Small Business Administration s SBA s Surety Bond Guarantee Program is designed to increase small businesses access to federal state and local government contracting as well as private sector contracts by guaranteeing bid performance and payment bonds for small businesses that cannot obtain surety bonds through regular commercial channels The program guarantees individual contracts of up to 6 5 million and up to 10 million if a federal contracting officer certifies that such a guarantee is necessary The SBA s guarantee ranges from 70% to 90% of the surety s loss if a default occurs In FY2014 the SBA guaranteed 12 384 bid and final surety bonds with a total contract value of about 6 4 billion A surety bond is a three party instrument between a surety who agrees to be responsible for the debt or obligation of another a contractor and a project owner The agreement binds the contractor to comply with the contract s terms and conditions If the contractor is unable to successfully perform the contract the surety assumes the contractor s responsibilities and ensures that the project is completed Surety bonds are viewed as a means to encourage project owners to contract with small businesses that may not have the credit history or prior experience of larger businesses and are considered to be at greater risk of failing to comply with the contract s terms and conditions P L 112 239 the National Defense Authorization Act for Fiscal Year 2013 increased the program s bond limit which had been 2 million since 2000 and was temporarily increased from February 17 2009 through September 30 2010 to 5 million and up to 10 million if a federal contracting officer certified in writing that a guarantee in excess of 5 million was necessary Advocates of

raising the program's bond limit argued that doing so would increase contracting opportunities for small businesses and bring the limit more in line with limits of other small business programs such as the 8(a) Minority Small Business and Capital Ownership Development Program and the Historically Underutilized Business Zone (HUBZone) Program. Opponents argued that raising the limit could lead to higher amounts being guaranteed by the SBA and as a result increase the risk of program losses. This report examines the program's origin and development including the decisions to 1) supplement the original Prior Approval Program with the Preferred Surety Bond Guarantee Program that provides a lower guarantee rate not to exceed 70% than the Prior Approval Program not to exceed 80% or 90% depending on the size of the contract and the type of small business in exchange for allowing preferred sureties to issue SBA guaranteed surety bonds without the SBA's prior approval and 2) increase the program's bond limit.

The 8(a) Program for Small Businesses Owned and Controlled by the Socially and Economically Disadvantaged Congressional Research Service, 2014-11-26

Commonly known as the 8(a) Program, the Minority Small Business and Capital Ownership Development Program is one of several federal contracting programs for small businesses. The 8(a) Program provides participating small businesses with training, technical assistance, and contracting opportunities in the form of set-asides and sole source awards. A set-aside is an acquisition in which only certain contractors may compete, while a sole source award is a contract awarded or proposed for award without competition. In FY2013, the federal government spent 14 billion on contracts and subcontracts with 8(a) firms. Other programs provide similar assistance to other types of small businesses, e.g., women-owned. HUBZone Eligibility for the 8(a) Program is generally limited to small businesses unconditionally owned and controlled by one or more socially and economically disadvantaged individuals who are of good character and citizens of the United States that demonstrate potential for success. Each of these terms is further defined by the Small Business Act regulations promulgated by the Small Business Administration (SBA) and judicial and administrative decisions. A business is generally a for-profit entity that has a place of business located in the United States and operates primarily within the United States or makes a significant contribution to the U.S. economy by paying taxes or using American products, materials, or labor. A business is small if it is independently owned and operated, is not dominant in its field of operations, and meets any definitions or standards established by the Administrator of Small Business. Ownership is unconditional when it is not subject to any conditions precedent or subsequent, executory agreements, or similar limitations. Control is not the same as ownership and includes both strategic policy setting and day-to-day administration of business operations. Members of certain racial and ethnic groups are presumed to be socially disadvantaged, although individuals who do not belong to these groups may prove they are also socially disadvantaged. To be economically disadvantaged, an individual must have a net worth of less than 250,000, excluding ownership in the 8(a) firm and equity in one's primary residence at the time of entry into the program. This amount increases to 750,000 for continuing eligibility. In determining whether an applicant has good character, SBA looks for criminal conduct

violations of SBA regulations or debarment or suspension from federal contracting For a firm to have potential for success it generally must have been in business in the field of its primary industry classification for two years immediately prior to applying to the program However small businesses owned by Indian tribes Alaska Native Corporations Native Hawaiian Organizations and Community Development Corporations are eligible for the 8 a Program under somewhat different terms The 8 a Program has periodically been challenged on the grounds that the presumption that members of certain racial and ethnic groups are disadvantaged violates the constitutional guarantee of equal protection The outcomes in early challenges to the program varied with some courts finding that plaintiffs lacked standing because they were not economically disadvantaged Most recently a federal district court found that the program is not unconstitutional on its face because breaking down barriers to minority business development created by discrimination constitutes a compelling government interest and the government had a strong basis in evidence for concluding that race based action was necessary to further this interest However the court found that the program was unconstitutional as applied in the military simulation and training industry because there was no evidence of discrimination in this industry
