- Types of Tance.
  - A. After income taxes, transaction taxes usually affect more US taxpayers than any other type of tax. In many countries, transaction lates are once pure important than income laters.

    - Excise Taxes:
      - Leviet by Federal and state governments on exchanges of specified commodities (oil, alcohol, alcohol, alcohol, and tohacce) or services.
      - fixcise taxes may be levied on predocers, resellen or consumers.
      - May have significant inspect on specific industries.
      - Although excise tax rates are generally proportional, they may vary greatly from state to state.
