Topic 7.1 Shifting Power After 1900

Learning Objective

Explain how internal and external factors contributed to change in various states after 1900.

Historical Developments

The West dominated the global political order at the beginning of the 20th century, but both land-based and maritime empires gave way to new states by the century's end.

The older, land-based Ottoman, Russian, and Qing empires collapsed due to a combination of internal and external factors. These changes in Russia eventually led to communist revolution.

States around the world challenged the existing political and social order, including the Mexican Revolution that arose as a result of political crisis.

1. Describe the factors that led to the collapse of the Ottoman Empire.

-had started to face troubles as imperialism began. In response established the **Tanzimat Reforms**: included measures such as abolishment of slave trade, introduction of new legal code, and centralized bureaucracy
 -Reforms failed and did not attack the root of the problems which were political corruption and Economic mismanagement
 -young turks: overthrew the government and implemented democratic reforms such as parliamentary system

2. Describe the factors that led to the collapse of the Russian Empire.

-was poor, agrarian, lagging in industrial development, lost the Crimean war which showed how much they had fallen behind in industrialization development
 -rapid railroad construction occurred which led to all the problems, low wages, long hours, dangerous conditions
 -revolution: Karl marx started up with ideas (social equalities, no private property, collective living, **proletariat** (working class) must overthrow the **bourgeoisie**)
 -were not well equipped when WWI broke out to fight strong states such as Germany which led to food shortages, massive casualties, poor weapons uniforms etc.
 -Revolution in Russia occurred due to food shortages etc., after fall of Nicholas II in 1917, massive chaos ensued-many different groups promoting their agendas and seeking power, provided opening for more radical groups such as the Bolsheviks led by Vladimir

3. Describe the factors that led to the collapse of the Qing Dynasty in China.

- Japan had modernized so much it was now a threat to China and led to the Sino-Japanese War where China was defeated
- The **Boxer Rebellion** (1899-1900) was another setback for Chinese
