Hitler's Shadow Empire Pierpaolo Barbieri, 2015-04-14

This plan was only possible and profitable because of Hitler's economic czar Hjalmar Schacht a wizard of international finance. His policies fostered the interwar German recovery and consolidated Hitler's dictatorship. Though Schacht's economic strategy was eventually abandoned in favor of a very different conception of racial empire Barbieri argues it was in many ways a more effective strategic option for the Third Reich.
