Step 1: Click on the **Register** link in the top right corner of the Westlaw.com homepage. This will take you to the registration page.



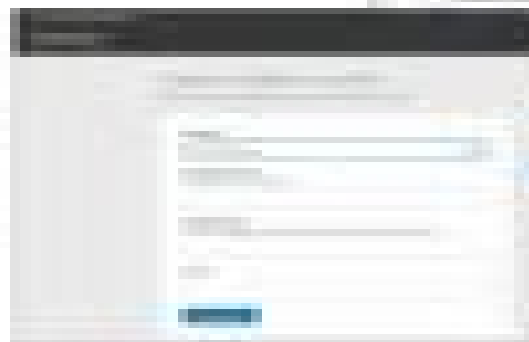
Step 2: Click on the **Create New Account** link in the top right corner of the registration page.
