tort laws - correct answer Originated from common law of England

Jurisdiction - correct answer legal authority that an entity possesses to make a legal decision

intentional tort: BATTERY - correct answer -intentional & nonconsensual contact with the plaintiff, intended "touching"

-may be liable for contact that physically harms plaintiff, but may also be liable for relatively minor contacts that are offensive or insulting

intentional tort: ASSULT - correct answer -conduct that causes apprehension of a harmful or offensive contact instead of actual contact

-apprehension or fear of battery may constitute an assault

intentional tort: FALSE IMPRISONMENT - correct answer -intentional confinement of another person against that persons will- right to leave, pull IV out

elements of intentional torts are.. - correct answer -absence of a reasonable means of escape

-no legal authority on the part of the person acting to confront another- no law that supports it

intentional tort: INTENTIONAL INFLICTION OF EMOTIONAL DISTRESS - correct answer -emotional distress

-sleeplessness, anxiety, irritability, or the emotional inability to perform activities or of places that plaintiff was capable of prior to event for which a lawsuit has been filed.

Intentional infliction of emotional distress

Elements are: - correct answer - an intentional or reckless act

-extreme and outrageous conduct that is beyond the standards of civilized decency or is utterly intolerable in a civilized society

-act that the defendant must have actually caused the emotional distress
