The arrival of the Spaniards altered a subsistence economy, for which they imposed the payment of tributos (tributes) from the Filipinos. The purpose is to generate resources to finance the maintenance of the islands, such as salaries of government officials and expenses of the clergy. Reduccion was introduced by the Spaniards by creating pueblos, to collect revenue from the Filipinos. Exempted from payment of tributos were the principals: alcaldes, gobernadores, cabezas de barangay, soldiers, and members of the civil guard, government officials, and vagrants. In the sixteenth century, the Manila-Acapulco trade was established through the galleons, a way by which the Spaniards could make sure that European presence would be sustained.
