She is not VAT-registered and instead pays 3% OPT on her gross receipts under Section 116 of the Tax Code.

The amount she received from CPAR University is inclusive of 13th Month Pay and other benefits of P165,000.

She also wrote a book entitled "SINGLE LIFE IS HEAVEN" which became a bestseller in the Philippines. In 2019, she earned royalties from the book in the amount of P2,500,000, net of the 10% final tax. Using this amount, she opened a time deposit with BDO which earned interest income of P75,000, net of the 20% final tax.
