Defined benefit plans

- Lesser of \$210,000 or 100% of the participant's average compensation for his/her three high consecutive years of active plan participation.

SEP IRA contribution limits

- Discretionary employer contributions of up to the lesser of \$53,000 or 25% of employee compensation or 20% of net earnings from self employment.*
- A minimum of \$600 in compensation required to participate in SEP.

Maximum contributions

Highly compensated employee

- A highly compensated employee is a person who was a 1% owner at any time during the determination year or the preceding year, or for the preceding year received more than \$120,000 in compensation from the employer and, if the employer elects, also was in the "top-paid group" (top 20%) of employees for that year.*
- Key employee – officer: \$170,000.

* In Puerto Rico, no "top-paid" election is available.

Saver's tax credit

- Single taxpayers and married individuals filing separately with MAGI below \$30,500, heads of household with MAGI below \$40,750 and joint filers with MAGI below \$61,000 may be eligible for a tax credit for an IRA, 401(k), 403(b) or 457 employee plan contribution, in addition to any deduction or exclusion that would otherwise apply.
