Agriculture - Farming.

Articles of Confederation - 1st Constitution of the U.S. 1781-1788 (weaknesses-no executive, no judicial, no power to tax, no power to regulate trade)

Anti-Federalist - a person opposed to the ratification of the US constitution, and wanted a bill of rights to be added.

Federalist - supporters of the constitution during the debate over its ratification; favored a strong national government

Bill of Rights - The first ten amendments of the U.S. Constitution, containing a list of individual rights and liberties, such as freedom of speech, religion, and the press.

Constitution - The document which established the present federal government of the United States and outlined its powers. It can be changed through amendments.
