To Whom It May Concern:

As the Chief of Police of the San Diego Police Department, I am writing to strongly urge you not to grant parole to Jesus Cecena who was convicted of murdering our San Diego Police Officer Archie Buggs in 1978.

Officer Buggs was devoted to helping people and saving lives. He was keeping the citizens of our City of San Diego safe from brutal gang members like inmate Jesus Cecena when he was savagely shot and killed, execution style.

Violence against law enforcement officers is on the rise and many officers have lost their lives to parolees. I cannot state strongly enough, inmates who have taken the life of an officer should be subject to serve their full sentence, without any possibility of parole.

Inmate Jesus Cecena has already been denied parole in the past, and it is imperative that parole continue to be denied. He is a cold blooded killer who poses a clear danger to the citizens of California.

Cecena brutally took the life of a public servant and significantly affected the lives of Officer Buggs family, friends, co-workers and the entire law enforcement community. We urge you to keep this brutal killer behind bars for the public safety of all Californians and deny parole for Jesus Cecena. Justice demands that he be made to spend every day of his life in prison.
