PART III turns to drafting rules for good writing and to techniques for enhancing clarity and avoiding ambiguity. PART V shows students how to integrate everything they have learned: how to organize a contract, how to use precedents, and how to review and comment on a contract. PART VI addresses ethical issues that arise in drafting. PART VII provides additional exercises, presents a five-prong framework for considering business issues that appear in almost every transaction, money, risk, control, standards, and endgame. Chapter 17, *Adding Value to the Deal*, includes plentiful examples of well-drafted provisions, many based on commercial agreements, provides exercises for use in or out of class individually or collaboratively, including contract mark-ups, new drafting, and both combined into a single exercise.
