in the Collective Agreement can be included here I hope this Employee Handbook will facilitate the process of updating your Company's Handbook in Companies where this exists and the development of new Employee Handbooks in Companies and in countries where such Handbooks are being developed for the first time This will obviate the need for engaging an experienced Human Resource Consultant to develop such a Handbook thereby saving the Company several thousand dollars

LSOM Note To make the Handbook even more comprehensive you could have a section for Executives and Management who enjoy perks not extended to the Non Exempt employees Also you could specify the maximum basic salary beyond which the employee is not qualified to receive overtime The section on Executive Management perks should only be distributed to the personnel concerned Perhaps the most important clause is to incorporate the following into the Employee Handbook

Changes may need to be incorporated in this Handbook relating to your terms and conditions and where these are required these will be communicated to you because these will then form a part of your contract of service

IMPORTANT The Management should ensure all employees acknowledge receipt of the Employee Handbook and file the acknowledgement in the respective employee's personal folder
