How to Handle Goods and Service Tax (GST) Dr. DK Sukhani,2017-06-23 GST is a value added tax levied at all points in the supply chain with credit allowed for any tax paid on input acquired for use in making the supply It would apply to both goods and services in a comprehensive manner with exemptions restricted to a minimum In keeping with the federal structure of India it is proposed that the GST will be levied concurrently by the central government CGST and the state government SGST It is expected that the base and other essential design features would be common between CGST and SGSTs for individual states The inter state supplies within India would attract an integrated GST IGST which is the aggregate of CGST and the SGST of the destination state GST would be levied on the basis of the destination principle Exports would be zero rated and imports would attract tax in the same manner as domestic goods and services In addition to the IGST in respect of supply of goods an additional tax of up to 1% has been proposed to be levied by the central government The revenue from this tax is to be assigned to the origin states This tax is proposed to be levied for the first two years or a longer period as recommended by the GST Council With GST it is anticipated that the tax base will be comprehensive as virtually all goods and services will be taxable with minimum exemptions GST would bring in a modern tax system to ensure efficient and effective tax administration It will bring in greater transparency and strengthen monitoring thus making tax evasion difficult While the process of implementation of GST unfolds in the next few months it is important for industry to understand the impact and opportunities offered by this reform GST will affect all industries irrespective of the sector It will impact the entire value chain of operations namely procurement manufacturing distribution warehousing sales and pricing
