The NRC staff based its recommendation on the following factors: the NRC staff's review of the NWMI Environmental Report and responses to requests for additional information; the NRC staff's consultation with Federal, State, and local agencies and Tribal officials; the NRC staff's independent environmental review; and the NRC staff's consideration of public comments.
