Stapleton, 2006-04-21 **No Insignificant Part** The Rhodesia Native Regiment and the East Africa Campaign of the First World War is the first history of the only primarily African military unit from Zimbabwe to fight in the First World War Recruited from the migrant labour network most African soldiers in the RNR were originally miners or farm workers from what are now Zimbabwe Zambia Mozambique and Malawi Like others across the world they joined the army for a variety of reasons chief among them a desire to escape low pay and horrible working conditions The RNR participated in some of the key engagements of the German East Africa campaign's later phase subsisting on extremely meager rations and suffering from tropical diseases and exhaustion Because they were commanded by a small group of European officers most of whom were seconded from the Native Affairs Department and the British South Africa Police the regiment was dominated by racism It was not unusual for black soldiers but never white ones to be publicly flogged for alleged theft or insubordination Although it remained in the field longer than all white units and some of its members received some of Britain's highest decorations the Rhodesia Native Regiment was quickly disbanded after the war and conveniently forgotten by the colonial establishment Southern Rhodesia's white settler minority partly on the strength of its wartime sacrifice was given political control of the territory through a racially exclusive form of self government but black RNR veterans received little support or recognition **No Insignificant Part** takes a new look at an old campaign and will appeal to scholars of African or military

Tracing the dynamics of land and power from precolonial times together with their entanglement with colonial policies is important for this relationship is almost always neglected by both scholars and policymakers drawn to the high drama of colonial and postcolonial politics of land. This oversight has real consequences on our understandings of landed inequalities and how they are addressed. When Zimbabwe's postcolonial state focused on colonially induced racialized land inequalities, its land reform efforts left older forms of landed inequalities based on gender, generation, and ideas of belonging intact. The book, which details these inequalities, reminds Zimbabweans and others that if the quest for equity espoused in postcolonial land reforms is to be meaningful, it must be attentive to both colonially induced inequalities and those enduring disparities that predated, were deepened by, and outlived colonial rule. At the same time, Zimbabweans who now live with a postcolonial state that is increasingly centralizing power over land may well learn from past societies' creative efforts to limit the authority of their leaders. *Urban Social Capital* Gregory W.
