    - 3. Buy 5,000 jackets at VAT- inclusive price of 54,000 VND/unit.
    - 4. Buy 500 hats at VAT- inclusive price of 27,000 VND/unit.
  - Output
    - 1. Sell 2,000 T-shirts to retailers at VAT- inclusive price of 108,000 VND/unit.
    - 2. Sell 4,000 jackets to supermarkets at VAT- exclusive price of 162,000 VND/unit. In addition, the company does a sales promotion in the form of "buy 10 jackets get 01 hat free". The sales promotion is conformable with trade laws.
