Advance payment of tax and tax deducted at source

Advance payment of tax and tax deducted at source (TDS) are two different concepts related to income tax.

Advance payment of tax refers to the payment of income tax in advance before the end of the financial year. This is usually done by taxpayers who expect to have a tax liability at the end of the year, based on their income and deductions. The payment of advance tax is mandatory for taxpayers whose tax liability is expected to be more than Rs. 10,000 in a financial year. Failure to pay advance tax can result in interest charges and penalties.

On the other hand, TDS refers to the tax deducted at source by the person making the payment. This is usually done by employers, banks, and other financial institutions when they make payments such as salary, interest, rent, or commission, to name a few. The TDS amount is then deposited with the government on behalf of the recipient.  - a. **Scrutiny Assessment:** This is when the Income Tax Department examines the taxpayer's ITR in detail and may ask for additional information, documents or clarification on any issues related to the return.
