1970

The Bank Secrecy Act

Reporting and record-keeping requirements for US banks and financial institutions introduced.

1973/4

Supreme Court Challenge

The California Bankers Association v. Schultz: Complainants challenging BSA on 1st, 4th, and 5th Amendment constitutional grounds.

1976

Second Supreme Court Challenge

The Supreme Court overturns a 5th circuit appeal and rules that the BSA permits law enforcement authorities to access customer bank records.

2021

Anti Money Laundering Act 2020 (AMLA)

The Anti Money Laundering Act 2020 introduces BSA regulations for cryptocurrencies and shell companies and expands and increases AML compliance penalties.

Congress moves to modernize the BSA and AML compliance requirements.

1996

Suspicious Activity Reports

The BSA suspicious activity reporting obligation is standardized with the form that became known as the Suspicious Activity Report (SAR).

2001

US Patriot Act

New identity verification and information sharing requirements in the wake of the 9/11 terror attacks introduced.
