Convicted felons sentenced to a prison term of more than 1 year



Drug users or addicts



Fugitives from justice



People legally declared to be mentally-ill or have been committed to a mental institution



Illegal alliens



People dishonorably discharged from any branch of the U.S. Armed Forces



Former US citizens who have renounced their citizenship



People subject to court restraining orders issued on behalf of their 'intimate partners,' their partner's child, or children.



People convicted of a misdemeanor crime of domestic violence



If you're not legally allowed to own a gun, you cannot buy or own bullets as well.



Federal law prohibits anyone under 18 from possessing a handgun or handgun ammunition.



Gun buyers have to go through a national background check before they can legally purchase one from a licensed gun store.



Gun shows: both federally licensed dealers and unlicensed sellers can sell guns at temporary gun shows, and everyone can just buy guns without background checks or registrations.



Gun laws vary from state to state.



There are two ways citizens can carry firearms: open carry and concealed carry. A casual observer can see the gun with the former, and cannot see the weapon with the latter.
