En concreto se incluye un capítulo sobre la evaluación psicológica en el ámbito forense, Capítulo 4 el testimonio, Capítulo 5 el informe pericial, Capítulo 6 la entrevista cognitiva, Capítulo 7 la simulación, Capítulo 8 y sobre métodos alternativos en la solución de conflictos y mediación, Capítulo 9. Finalmente el capítulo 10 se dedica a los principios éticos y deontológicos propios de la práctica pericial que todo profesional en este ámbito debe considerar.
