3. Step 3: Log in to your account. Once you have verified your email address, you can log in to your account. You need to enter your username and password.

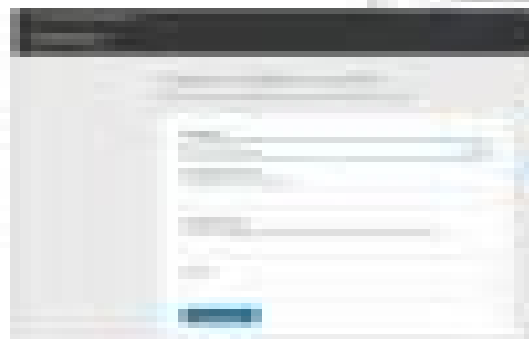
