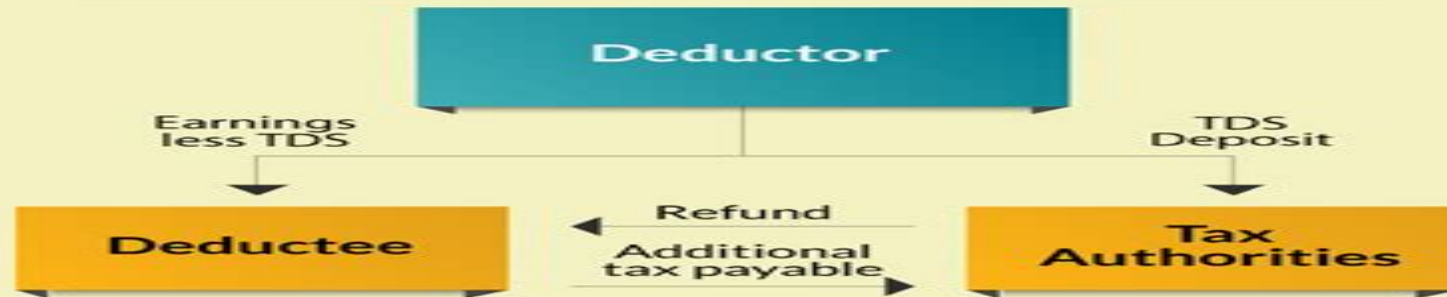


TAX DEDUCTED AT SOURCE (TDS)

TDS is a direct taxation mechanism using which various types of income is taxed before actual payout occurs

COMMON TYPES OF INCOME SUBJECT TO TDS, RATE OF TAXATION AND THRESHOLD LIMITS

Various types of income subject to TDS are mentioned in Section 192 to Section 194 and its various subsections of the Income Tax Act, 1961.

The following are 5 common income/earnings that are subject to TDS

TYPE OF INCOME/EARNINGS	RATE OF TAXATION	THRESHOLD LIMIT (ANNUAL)
Salary Income	As per Income Tax Slab Rate	As per Income Tax Slab
Bank FD Interest Income	10%	Rs. 10,000 for individuals aged less than 60 years/Rs. 50,000 for senior citizens
Winnings from lottery, horse races, crossword competitions, etc.	30%	Rs. 10,000
Premature withdrawal of Employee Provident Fund	10% (20% without PAN)	Rs. 50,000
Income from Royalty, Professional or Technical Services provided	10%	Rs. 30,000
