- **Property v. Resources:**
 - Property is the idea that you have the right to exclude others from your stuff (what you consider to be your property) while resources are the actual stuff you can exclude people from.
 - Implicit vs. explicit concepts of property
- **Scarcity:** the need for resources outstrips the supply of those resources
 - Driving factor for our economy
- **Private property establishes necessary conditions for capital formation**
 - Capital: investments made today that will pay off in the future
 - How does this work?
 - There is a loan for a business, and someone puts their house up for collateral
 - Can convert the rights in one resource into the rights in a different resource for the purpose of starting a business.
- **Real Property v. Personal Property**
 - Real: land, interests in land, buildings, (surface, air subsurface, fixtures)
 - Personal: movable resources (tangible and intangible)
- **Acquiring Property:**
 - Exchange: most common method, buying things, providing services, contracts
 - Possession:
 - Un-owned (includes abandoned): Rule of First Possession
 - Lost: you own it until the rightful owner comes back for it (may need to provide to police), if something is truly lost, it is "finders keepers"
 - Mislaid: the owner of premises and the owner can come back for it, and the one who found the material should turn them over to the establishment item was lost in.
 - If you mislay something, you somewhat know where you put it.
 - Neglected land: adverse possession (think squatters rights)
 - Open and notorious: not secretive
 - Continuous: uninterrupted for a fixed period of time
 - Exclusive: the sole occupation of land
 - Actual: physical presence on the land
