- 1. Basic Judicial Requirement:
 - Jurisdiction (Quyen thus thi phap by): Court's authority to hear and decide the case
 - + Jurisdiction over Persons or Property:
 - Authority to decide dispute involving persons or business that resides in the court's geographic area.
 - Long arm statutes (36):
 - A court can exercise personal jurisdiction over certain out-of-state defendants based on activities that took place within the state.
 - The court must be convenced that the defendant had sufficient contacts, or missions contacts, with the state to justify the jurisdiction.
 - A state may exercise personal jurisdiction over a nonresident defendant who is sued for breaching a contract that was formed within the state
 - Corporate Contacts (37):
 - A corporation normally is subject to personal jurisdiction in the state in which it is incorporated, has its principal office, and is along business (such as advertising or selling products)
 - A corporation is subject to jurisdiction only in states where it aloes such substantial and continuous business that is "at home" in that state. The court look at the amount of business the corporation does within the state relative to the amount it does elssewhere.
 - Jurisdiction over Subject Matter: a limitation on the types of cases a court can hear.
