
Are All Bank Accounts Insured by the FDIC?



- Not all banking institutions are insured
- Insured accounts include negotiable orders of withdrawals, money market accounts, and certificates of deposit
- Depositors are insured up to \$250,000 per institution, regardless of how many accounts they have open
- Credit union accounts are insured by the NCUA, not the FDIC, also up to \$250,000 per depositor
