

Costs in the Supreme Court

This guidebook provides an overview of the procedure for estimating costs in Supreme Court cases. Costs are usually awarded to the party who is successful at trial. They are awarded to the party who prevails by legal fees and those spent on a witness or expert at a hearing or trial, or on a witness or expert who has travelled to court. The rules that govern costs are set out in Rule 4 – Civil Procedure for the Supreme Court Rules, (and costs awarded before preparing final documents).

Some Canadian federal courts have their own rules on how to estimate costs and how to estimate attorney’s fees. These rules are sometimes adopted by the Continuing Legal Education Society of BC and the Canadian Judicial Council. If you are a Justice of the Peace, Municipal Officer, or Justice of the Peace, you should check the rules that apply to a hearing about the amount of costs.

What are costs?

The court may award costs to a successful party. In that case, the successful party for the documents filed at the trial pays expenses incurred by the other party, plus fees spent on witnesses or experts at a hearing or trial. They are called “party and party” costs. Usually, if you are a party to a Supreme Court case and are successful, you should be awarded at a trial, costs equal to that of the other party pay your costs.

The general rule is that the amount of costs allowed on the fact sheet in Appendix B of the Supreme Court Rules, plus disbursements. Occasionally, if there has been exceptional conduct in the course of the trial, such as fraud, the court may order that special costs be paid to the successful party. Special costs are higher and awarded to successful litigants. They do not apply for special costs if you are not represented by a lawyer.

Getting an order for costs

At trial, the judge will order the successful party to pay all of the costs, set by your order of judgment, which you must ask the court for. If you are not successful, you may ask the court for costs or disbursements, or both. The court will order you to pay costs or disbursements, or both.
