Rather than upholding US dominance France supports a multipolar order that will also reduce China's influence in the region with France acting as a balancing power and offering an alternative to the choice between China and the United States Japan and India show interest in European views with the former leaning more toward its allies the US and AUKUS and the latter seeing Europe less as an alternative to the status quo and more as a complement of QUAD This book concludes that the US needs to build coalitions rather than forcing allies and neighbors to choose sides while Japan Asian countries and Europeans should more actively reform the LIO
