This allowed us to maintain financial stability throughout each quarter. The company slowly introduced new stores and slowly invested in 3D printers to increase Fixed Capacity as needed and fundings these investments with the ending cash funds from the previous quarters including retained earnings. This allowed For the Love of Bikes to avoid the need for emergency loans and even prevented bankruptcy. We also never had any leftover products and instead grew to understand the increasing demand of these products to make necessary changes to the price, safety, and needs of our customers. This allowed For the Love of Bikes to obtain a high percentage of the market shares and sales in the 3D bike segments. This also provided a financial advantage over other companies as each quarter, we continued observing the increased demand of our products and made changes to the tactical plan as needed.
