CHAPTER 1: INTRODUCTION TO TAX

What Qualifies as a Tax?

- **Tax** = payment required by a gov't that is unrelated to any specific benefit or service received from the gov't, where the general purpose is to fund gov't operations.
 - o **Sin taxes** = impose high surcharges on alcohol/tobacco products.
- Components of tax payments:
 - o Required
 - o Imposed by gov't agency (federal, state, local)
 - o Not tied directly to the benefit received by the taxpayer.
 - Doesn't mean that taxpayers receive no benefits from paying taxes.
 - They benefit from national defense, a judicial system, law enforcement, gov't-sponsored social programs, interstate highway system, public schools, etc.
- **Earmarked tax** = tax that is assessed for a specific purpose.
 - o Why is this considered a tax? = payment does not directly relate to the specific benefit received by taxpayer.

How to Calculate Tax

$$\text{Tax} = \text{Tax Base} * \text{Tax Rate}$$

- **Tax base** = defines what is actually taxed and is usually expressed in monetary terms.
- **Tax rate** = determines the level of taxes imposed on the tax base and is usually expressed as a percentage.
- **Flat tax** = Single tax applied to an entire base. (proportional tax)
- **Graduated tax** = the base is divided into a series of monetary amounts (brackets) and each successive bracket is taxed at a different (gradually higher
